**1.0 PURPOSE**

To provide consistent guidance for Four Rivers Nuclear Partnership, LLC, (FRNP), in evaluation and approval of payment of water bills for those properties within the water policy area.

**2.0 POLICY**

This policy applies to all landowners within the water policy area that are provided access to municipal water through Paducah Water.

**3.0 IMPLEMENTATION**

Based upon a water bill statement of \$100 or greater for any landowner, unless the historical use was established at the time of the initiation of the water policy, the following actions shall be taken:

- 3.1** First occurrence: Contact landowner by phone regarding the water bill amount and advise the landowner that there may be a leak present. Notify the landowner that the water bill amount is elevated, and if the excessive use is due to a leak, then the landowner is responsible for repair of water lines. Explain the policy on high water bills over \$100 and that the U.S. Department of Energy will only pay up to \$100 on the third occurrence of the water bill being over \$100. Follow up conversation with a written Notification of High Water Bill letter (Appendix A).
- 3.2** Second occurrence: Contact landowner by phone regarding the water bill amount and send a Notification of Excessive Water Usage letter (Appendix B) notifying landowner that \$100 is the maximum amount that will be paid toward any future water bills at that residence.
- 3.3** Third occurrence: Contact the landowner by phone regarding the amount over \$100 that the landowner is responsible for and remind the landowner that this amount is due to the Paducah Water. Notify the infrastructure contractor to pay only \$100 toward the landowner's water bill. Pay only \$100 toward the landowner's water bill.

##### **4.1 Definitions**

Water Policy Area – An area with a northern boundary of the Ohio River, an eastern boundary of Metropolis Lake Road (includes both sides of Metropolis Lake Road), with a southern boundary of Ogden Landing Road (includes both sides of Ogden Landing Road) and western boundary of Bethel Church Road (includes both sides of Bethel Church Road).

**Notification of Excessive Water Usage—Name**

Four Rivers Nuclear Partnership, LLC, (FRNP) acting pursuant to its contract with the U.S. Department of Energy (DOE), would like to inform you that your water usage for your property located at (address) has been noticeably high when compared with average water bills for single-family dwellings within the Water Policy Area.

An FRNP representative contacted you on (date), and discussed the increased water usage for your property compared to historical usage rates. As noted in your discussion with the FRNP representative, you are responsible for maintaining and properly and promptly repairing water lines on the property, including any leaks or water-line breaks.

The current license agreement on file for your property is enclosed for your reference. Please note Condition 10b on page 3 of the license agreement. Payment of your water bill is limited to reasonable, single-family residential usage for the residence based on historic residential use at the property. Your usage appears to be inconsistent with this standard.

As of the date of this letter, any excessive amount will be considered unreasonable for your property. From this date forward, DOE will pay Paducah Water for your monthly water usage up to \$100. You will be responsible to the Water District for any exceedance of that amount.
